



REGULATIONS

Arrivals: 8:30am-11:00pm. For customers in accommodations: 04:00pm-11:00pm. All guests must show an up-to-date identity document at the reception for standard legal registration purposes.

Departures: check out of the pitch and the accommodation: by 10:00am. Departures after this hour involve the payment of the rate of the following night. Guests in accommodations must return the key from 08:30am to 10:00am.

Cash desk: 8:30am-10:00am and 04:00pm-06:00pm.

Discounts: all the discounts are calculated according to the nights spent, and not to the nights booked.

Silence: 11pm-07am. It is forbidden to drive motor vehicles in the campsite during the silence-time. All unnecessary noises and disturbances should also be avoided (radios, televisions...).

Dogs and other pets: dogs should always be kept on a lead within the camping ground, taking care that they do not create disturbances. Damages caused by pets will be charged to the respective owners. The management declines all responsibility. Pets are strictly forbidden in the swimming pool area, in the accommodations and in any other campsite building.

Speed limit: the maximum speed limit in the campsite is 10 km/h.

Responsibility: the campsite declines full responsibility for damages to persons or objects caused by bad weather, Acts of God, epidemics, insects, plant diseases or any other damage that is not caused directly by negligence on behalf of campsite personnel. The use of equipment is at personal risk and danger. Parents are held directly responsible for their children. The management declines full responsibility for losses, theft or damages. These regulations may be modified with the addition of rules that the management declare necessary.

Bookings: bookings can be made by letter, telephone, fax and e-mail. Minimum length of stay in the high season: 5 nights for the pitches and 7 nights (from Saturday to Saturday) for the lodgings (3 nights minimum in the low season). In order to accept the reservation, a deposit of 120,00€ (for the pitches) and of 200,00€ (for the lodgings) per bank transfer, credit card or postal order is needed. The management will confirm the booking by letter, fax or e-mail.

Cancellation of the booking: cancellations can be made by fax, or e-mail within 30 days before the date of arrival. In this case the deposit will be returned except for 20,00€ as booking costs.

If the cancellation is made during the 29 days before the beginning of the stay, the deposit (minus euro 20,00 of booking costs) will be refunded only if the customer can certify an illness. Otherwise, the deposit will either be kept for the following year, or lost. If the pitch for tent/caravan/camper or the lodging is not occupied within 2 days after the scheduled date of arrival, the camping can hire it to somebody else. **Anticipated departures** referring to the booked dates involve:

- for the accommodations: **the whole price** till the date of departure originally booked;
- for the pitches: the **daily rate of the pitch + the rate for 2 adults, up to 3 nights.**

ACCOMMODATIONS

Equipment of the accommodations: all the accommodations are equipped with table and 5 chairs, 2 deck chairs, TV with satellite, microwave oven, pots and kitchenware, shower, wc, warm and cold water, heating. Bed-linen can be hired on request. Towels are not provided.

Deposit: a deposit of 100,00€ cash is required. It is to be returned at the end of the stay, after the staff have inspected the accommodation, if no damages to the lodging and its furniture have occurred.

Check of the accommodation: guests must make an appointment at the reception the day before leaving, and the check will take place at the leaving time together with the delivery of the key and anyway only in the following time: 08:30am-10:00am.
